- 4.4 Where a Member is alleged to have violated this Code of Conduct, and appropriate means to address the matter are not provided in the Act, any By-laws, or Member Policies, the Chair or the Vice-Chair, as the case may be, to whom the violation was reported shall investigate the allegation and submit their report to the Executive Committee of the Board as quickly as reasonably possible in the circumstances.
